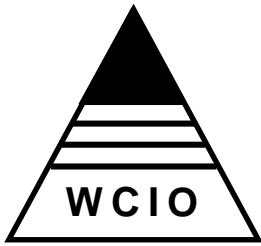
WCIO WEB SITE ANNOUNCEMENT
