RE: WI Class Code Changes – Transition Program

Three separate Circular Letters announced class codes that will be eliminated subject to the transition program beginning with the 10-01-2016 rate revision. Of the 5 codes subjected to the transition program, 3 were transitioned and eliminated; 2 will continue. Here is a summary of the code changes.

Circular 3139 – April 21, 2016

Class code 2913 will be retained and the rate will be **increased** up to the swing limit of 25% with each rate revision until the class rate matches closer to class code 2883. Code 2913 will then be eliminated and employers will be reassigned to code 2883.

NOTE: To be consistent with other class code changes in the review, no transition program was used as the rate for code 2913 was higher than 2883. Code 2913 was eliminated.
