RE: Class Code Clean-up – Rollerskating – Code 9093 Vs 9016

Pursuant to ch. 626, Wis. Stat., the Office of the Commissioner of Insurance has approved the following changes adopted by the Governing Board. The changes are effective 12-27-23, applicable to new and renewal business only.

Class Code Clean-up – Rollerskating proposed updates to the phraseology language in the 9016 class code to remove SKATING – ROLLER RINK from the class code as it is already addressed in the 9093 class code.

Class Code: 9016

- **AMUSEMENT PARK OR EXHIBITION OPERATION & DRIVERS** - Applies to the operation by owners or lessees and includes musicians and box office employees. Operation or maintenance of amusement devices to be separately rated. The two foregoing classifications Codes 9180 and 9016, do not apply to amusements, exhibitions, or other operations separately classified in this manual, such as bathhouses, billiard halls, boat livery, bowling lanes, garages, restaurants, retail stores or theaters, whether operated by the owner or lessee of the exhibition or amusement park or through independent concession.
- **CAVES OR CAVERNS-OPERATION FOR EXHIBITION PURPOSES & DRIVERS** - Includes guides, ticket sellers, gate attendants, maintenance employees.
- **CLUBS - SKI - ALL OTHER EMPLOYEES**
- **CONCESSIONS - BOATS IN PARKS**
- **COUNTY AGRI SOCIETIES**
- **DOG SHOW OPERATION BY OWNER OR LESSEE & DRIVERS** - Includes musicians and box office employees. Operation or maintenance of amusement devices to be separately rated as Code 9180-Amusement device operation NOC.
- **EXHIBITIONS** - See Amusement Park.
- **GAMES** - See Recreational Facilities.
- **GOLF DRIVING RANGES** - See recreation.
- **GUIDES - TOUR - TRAVELING**
- **HORSE SHOW OPERATION BY OWNER OR LESSEE & DRIVERS** - Includes musicians and box office employees. Operation or maintenance of amusement devices to be separately rated as Code 9180-Amusement device operation NOC.

- **ICE-SKATING RINK OPERATION & DRIVERS** - Applies to the operation of ice-skating rinks by owners or lessees and includes musicians and box office employees. Operation or maintenance of amusement devices to be separately rated as Code 9180- Amusement device operation NOC.
- **PONY RIDES - CARE & MAINTENANCE OF TRACK ETC.**
- **RACE TRACK OPERATION - CAR & MOTORCYCLE** - Includes ticket sellers & stand maintenance.
- **RACETRACK OPERATION HORSE OR DOG ALL OTHER EMPLOYEES INCLUDING STARTERS AND THEIR ASSISTANTS, DRIVERS**
- **RECREATIONAL FACILITIES OR AMUSEMENT DEVICES** - Includes archery ranges, ball or dart throwing, baseball batting ranges, miniature golf courses, golf driving ranges, shooting galleries using air rifles (no fire arms), public tennis courts (not municipal),.
- **RODEO - HORSE SHOWS - ALL OTHER EMPLOYEES**
