WCRB Rating Committee Meeting

Antitrust Statement - "This Board meeting has been called to discuss the items of mutual interest and concern to the members of the Wisconsin Compensation Rating Bureau. In accordance with both Federal and Wisconsin State Anti-trust Laws, this Committee is prohibited from any discussion or action which constitutes any form of boycott, coercion, or intimidation."

NEW BUSINESS

 Item B-1451-Revisions to NCCI's Basic Manual Rules and Classifications Related to Clerical Telecommuter Employees. The language explaining Class Code 8871 in the WI Basic Manual, though similar, differs from NCCI's Basic Manual. Because of these differences, the WCRB has worked to match the changes proposed in the NCCI filing into the WI Basic Manual. The Rating Committee approved the proposed language changes along with some minor grammatical corrections.

<u>UNFINISHED BUSINESS</u>

- Item B-1450—Revisions to Basic Manual Classifications for Hazardous Material Remediation and Military Reservation—Construction—Iron or Steel Erection—Not Over Two Stories in Height. This filing has been approved by OCI effective January 1, 2026, applicable to new and renewal business only. This item is removed from the agenda.
- Long-Term Policies The WCRB received 123 long term policies in 2024. The
 WCRB received input from carriers regarding the discontinuation of long-term
 policies. The Rating Committee decided to remain consistent with national standards.
 This item is removed from the agenda with no action taken.
- Wrap-Up Endorsements. This item was not formally removed and inadvertently omitted from the agenda.

A member carrier is drafting an endorsement relating to premium collection activity for wrap-up policies. It is anticipated that the carrier will present the proposed endorsement at the December Rating Committee meeting.

 - o Budget Update

The Governing Board was presented with budget reports and were given the opportunity to ask questions about the information presented.

The Board voted to approve the amount of \$2,817,429 for the general operating expenses for the WCRB for the fourth quarter of 2025.

The Board was advised that the intervention efforts have been successful in lowering fines. Improvements have been observed, fine volume is consistently being monitored, and outreach is being done as needed.

Administrative Affairs

Succession planning is going well. WCRB recently hired a replacement for a key database administrator who will be retiring in January 2026.

There was a recent unexpected termination that required the intervention of legal counsel.

WCRB Office Changes Update - The WCRB is downsizing their current office footprint, construction started on September 4, 2025. Costs for furniture removal and replacement were included in the budget. The December meeting will most likely be virtual as the space may not be finished yet.

- WISPUR Update The Governing Board was updated on the progress of replacing the Spectrum system. Discovery and Sprint 0 are complete. Development SOW terms are being finalized with a September 15 target date. Sprint 1 and Sprint 2 are in progress. The Governing Board approved the revised development budget.
- Legislative Update General discussion regarding pending and potential upcoming legislative issues.
- WCRI Presentation Kathleen Fisher from Workers Compensation Research Institute discussed benchmarks, volatility and emerging trends for WI.
