UNFINISHED BUSINESS

- Item B-1451-Revisions to NCCI's Basic Manual Rules and Classifications Related to Clerical Telecommuter Employees. This filing has been approved by OCI effective July 1, 2026. This item is removed from the agenda.
- Wrap-Up Endorsement Presentation. A member carrier drafted a proposed endorsement relating to sole representation for wrap-up policies. The Rating Committee suggested changes clarifying the intent of the endorsement. It is anticipated that the carrier will present a revised endorsement at the March Rating Committee meeting.

NEW BUSINESS

OFAC Endorsement Presentation/Discussion. A member carrier presented a
proposed endorsement relating to Office of Foreign Asset Control (OFAC)
requirements. The Rating Committee agreed to form a group of carriers to draft a
Wisconsin OFAC endorsement. This draft endorsement will be presented at the
March Rating Committee meeting.

WCRB Governing Board Meeting

Antitrust Statement

- The group adopted the minutes from the September 4, 2025 meeting.
- Bureau Operations Industry Issues
 - Budget Update

The Governing Board was presented with budget reports and were given the opportunity to ask questions about the information presented.

The Board voted to approve the 2026 annual budget in the amount of \$12,608,301, and the amount of \$3,152,075.25 for the general operating expenses for the WCRB for the first quarter of 2026.

The Board was advised that the carrier intervention efforts have been successful in lowering fines. The WCRB is implementing additional review processes to avoid increases in fines. Improvements have been observed, fine volume is consistently monitored, and outreach is done as needed.

Administrative Affairs

Robert Baker of Wisconsin Manufacturers & Commerce (WMC) is our newest public Board member.

Bernard Rosauer announced the retirement of Tad Cleveland and Donna Knepper, scheduled for the first quarter of 2027. Knowledge transfer has been in process over the last year and will continue until their retirement dates. Tad and Donna are highly regarded for their knowledge and experience in the industry and will be missed.

WCRB's newest employee, who came about via employee referral, will be replacing our tenured database administrator in January 2026.

Jeffrey Bryden, CFA of Curi Capital, who has been the financial advisor in charge of Pool Fund assets for the last 45 years, will be retiring at the end of this year.

WCRB Office Changes Update - The WCRB suite remodel/downsizing project is almost complete. WCRB staff will be occupying the space after the first of the year.

 WISPUR Update - The Governing Board was updated on the progress of replacing the Spectrum system. The project is on track and on budget.

There was discussion on WCRB security controls. Internal and external annual security audits, best practices along with monitoring tools are all used to keep industry data safe.

- Audit Committee Vacancies. There are two vacancies on the Audit Committee. EMC may have someone interested. Society is our current member.
- Legislative Update General discussion regarding the Agreed Bill and the return of Administrative Law Judges to DWD.

WWCIP Activity

- RFP Process Enhancements WCRB provided an update on the upcoming RFP process. Portal testing will begin soon. The new RFP timeline Circular Letter is scheduled for release in January 2026.
- Pool Servicing Carrier Withdrawal West Bend Insurance Company has terminated their Servicing Carrier Agreement effective March 31, 2025. The final quarter of policy transfers was completed in September. This item is removed from the agenda.
- Charge-Off Request Molondros Roofing LLC \$115,596 SFM. The Governing Board approved the recommendation to charge-off the uncollectible balance. SFM abstained from voting.
- Charge-off Request HD Exteriors LLC \$134,524 EMC. The Governing Board approved the recommendation to charge-off the uncollectible balance. EMC abstained from voting.

Following the adjournment of the Governing Board meeting, the Board met in Executive Session.
